- Becker Presentation
 - Steps to becoming a CPA
 - Step 1: meet educational requirements
 - Step 2: apply to take the CPA exam
 - Step 3: study for the exam
 - Step 4: schedule the exam
 - Step 5: succeed
 - Education Evaluation Application
 - \$90 fee
 - Determines fulfillment of educational requirements needed to take the CPA exam
 - Exam section application
 - Exam section application fee of \$344.80
 - Apply for 1 exam section per application
 - Notice to Schedule will be valid for a limited amount of time
 - Must take exam section listed on NTs within time frame or fees paid are useless
 - Apply for uniform CPA exam on NASBA
 - Becker software assigns a calendar schedule of how to study for the exam
 - Prometric: book exam testing location 1-1.5 month in advance, do test drive 1 week before, arrive 30 minutes early (put belongings in locker), take picture of student, fingerprint, receive TSA security check
 - Required to sign an NDA for candidates
 - CPA exam facts
 - 4 hours each
 - Score to pass: 75+
 - 30 months to pass all 4 parts after receiving first test score
 - Per exam
 - MCQ Testlet 1
 - MCQ Testlet 2
 - TBS Testlet 3
 - Between testlet 3 and 4: allowed to take 15-minute off the clock break
 - TBS Testlet 4
 - TBS Testlet 5
 - Core: FAR, AUD, REG and discipline
 - Around 1—1.5 minute per MCQ
 - No points taken away when wrong, best guess

- Core sections
 - FAR (fin.acty. & reporting)
 - Expected study time: 80-100 hours
 - Moved content from FAR to BAR
 - AUD:
 - Expected study time: 80-100 hours
 - REG
 - Moved content from REG to TCP
 - 80-100 hours of studying approximately
- Discipline sections
 - Choose best one at the time of taking it
- Business analysis and reporting (BAR)
 - 100-120 hours of studying
- Information systems and controls (ISC)
 - 60-80 hours of studying
- TCP (tax compliance and planning)
 - 60-80 hours of studying
- You are not allowed to retake a test until you get your score back
- 2024 CPA exam
 - Blackout dates exist for CORE exam sections; you can't schedule and take the core exams on these dates
- Why should i do this?
 - Prestige, competitive edge, job flexibility, job security
- Western discount CPA
 - Becker.com/wmichPP
- When receiving CPA package, ORDER 1 TEXTBOOK AT A TIME FOR 1 DISCIPLINE
- If you don't pass the CPA exams, the package license is extended
